This privacy policy outlines how we collect, use, and protect your personal information when you use our services.

1. Definitions and legal references

1.1. Personal data (or data)

Any information that is directly, indirectly, or in connection with other information including a personal identification number allows for the identification or identifiability of an individual person.

1.2. Usage data

Usage data is information automatically collected through our website or third-party services, including your IP address, browser type, operating system, time and method of requests, response status, visit duration, page sequence, and device-specific details.

1.3. This website

In any case, we will gladly help to clarify the specific legal basis that applies to the processing, and whether the provision of personal data is a statutory or contractual requirement, or a requirement necessary to enter into a contract.

6. Understanding how long we have to keep your information

6.1. When we collect your personal information, we keep it for as long as required for the purposes we collected for. Sometimes, we might need to keep our personal information longer due to a legal obligation or based on your consent, however it won't be more than 5 (five) years.

6.2. Here's what that means in more detail. We will keep your personal information based on the purposes and reasons set out below:

- For contractual purposes: If we have concluded a contract with you, then we'll keep your information until the contract has been performed in full.

- For our legitimate interests: If we're using your personal information for purposes that are necessary and relevant to our business operations, we'll keep it as long as we need it for those purposes. You can learn more about these purposes within the relevant sections of this document or by contacting us.

- With your consent: We may be allowed to retain personal data for a longer period whenever you have given consent to such processing, unless you withdraw your consent.

- Legal obligations: we may be obliged to retain personal data for a longer period whenever required to fulfill a legal obligation or upon order of an authority.

6.3. Once the retention period expires, we permanently delete, anonymize, or aggregate personal data. After deletion, rights such as access, rectification, or portability cannot be enforced. However, where retention is required by AML laws or financial regulations, user requests for deletion may not override these legal obligations.

7. Your Rights Under Data Protection Laws

You have rights regarding your personal data under applicable data protection laws.

7.1. Subject to local laws, you may exercise the following rights:

- Withdraw your consent: You may withdraw your consent to the processing of your personal data at any time, where consent was the legal basis for processing.

- Access your data: You have the right to confirm whether we process your personal data and to access that data.

- Rectify your data: You can request correction or updating of incomplete, inaccurate, or outdated information.

- Request deletion, blocking, or anonymization: If your data is unnecessary, excessive, or not being processed in compliance with applicable laws, you may request that it be anonymized, blocked, or deleted.

- Data portability: Where applicable, you may request the transfer of your personal data to another provider.

- Request deletion of data processed on the basis of consent: You may request deletion of data processed solely with your consent, unless we are legally required to retain it.

- Know about third-party data sharing: You may request information about the public or private entities with whom we share your data.

- Object to processing: You may object to the processing of your data for direct marketing, profiling, or other purposes based on your specific situation.

- Understand the consequences of not providing consent: Where the provision of data is optional, you are entitled to be informed about the consequences of not providing consent.

7.2. We are committed to respecting your privacy rights and complying with applicable data protection laws in all jurisdictions where we operate.

8. How to exercise these right

8.3. At your request, we will inform you about those recipients.

9. The grounds on which we process your personal information

We can process your personal information solely if we have a legal basis for such processing. Legal bases are as follows:

- Compliance with a legal or regulatory obligation that lies with us;

- The carrying out of public policies provided in laws or regulations or based on contracts, agreements and similar legal instruments;

- The carrying out of a contract and its preliminary procedures, in cases where you are a party to said contract;

- The exercising of our rights in judicial, administrative or arbitration procedures;

- Protection or physical safety of yourself or a third party;

- Our legitimate interests, provided that your fundamental rights and liberties do not prevail over such interests.

10. Your privacy rights

- Obtain information on the possibility to provide or deny your consent and the consequences thereof;

- Obtain information about the third parties with whom we share your personal information;

- Obtain, upon your express request, the portability of your personal information (except for anonymized information) to another service or product provider, provided that our commercial and industrial secrets are safeguarded;

- Obtain the deletion of your personal information being processed if the processing is based upon your consent;

- Revoke your consent at any time;

- Oppose a processing activity in cases where the processing is not carried out in compliance with the provisions of the law;

- Request clear and adequate information regarding the criteria and procedures used for an automated decision; and

- Request the review of decisions made solely on the basis of the automated processing of your personal information, which affects your interests. These include decisions to define your personal, professional, consumer and credit profile, or aspects of your personality.

10.2. You will never be discriminated against, or otherwise suffer any sort of detriment, if you exercise your rights.

11. How to file your request

You can file your express request to exercise your rights free of any charge, at any time, by using the contact details provided at the start of this document, or via your legal representative.

12. How and when will we respond to your request

12.1. Prompt responses

We will strive to promptly respond to your requests. In any case, should it be impossible for us to do so, we'll make sure to communicate to you the factual or legal reasons that prevent us from immediately, or otherwise ever, complying with your requests. In cases where we are not processing your personal information, we will indicate to you the physical or legal person to whom you should address your requests, if we are in the position to do so.

12.2. Access or processing confirmation requests

If you file an access or personal information processing confirmation request, please make sure that you specify whether you'd like your personal information to be delivered in electronic or printed form. You will also need to let us know whether you want us to answer your request immediately, in which case we will answer in a simplified fashion, or if you need complete disclosure instead. In the latter case, we'll respond within 15 days from the time of your request, providing you with all the information on the origin of your personal information, confirmation on whether records exist, any criteria used for the processing and the purposes of the processing, while safeguarding our commercial and industrial secrets.
